

**CLARKSVILLE-MONTGOMERY COUNTY SCHOOL SYSTEM
2009-10 SURVEY OF FEDERALLY CONNECTED STUDENTS**

Dear Parents and Guardians:

Your completion of the this survey allows us to identify parents or guardians who work and/or reside on Federal Property. This information is necessary to help schools receive federal funding that aids in the operation of CMCSS Schools. Although the federal government requires schools to capture and submit the number of federally connected students for the Impact Aid formula, the funds are provided based on land used by the federal government. We urgently request that you complete this form for each child even if you do not work or live on Federal property (Fort Campbell, government buildings, TVA steam plants, etc.).

Schools are not eligible for federal funding from Impact Aid if this form is not completed and signed by the parent/legal guardian. Information reported on this card has no effect on personal income or taxes. The information is kept strictly confidential and is used only in the Federal Impact Aid formula.

The amount received per federally connected student is approximately \$430. CMCSS spends about \$7,500 to educate each child. Even though Impact Aid funds represent a small part of the budget, the funds are significant to students. All students of CMCSS benefit as a result of this survey and revenue.

Please ask your child to return this form to his or her teacher immediately. Thank you for you time and cooperation.

Instructions:

Section 1. Student Information. Please enter the requested data for your child. If the student's address is on Federal Property, check Yes and check the appropriate facility.

Section 2. Parent Information: Civilian Employees. Complete this section only if the parent, step-parent, or legal guardian works on Federal Property or reports to work on Federal Property, and lives with the student. If employed by private contractors but working on federal property, such as Ft. Campbell, list the contractor company name and the address on the federal property.

Section 3. Parent Information: Active Duty Military. Complete this section only if the parent, step-parent, or legal guardian was ACTIVE duty military on October 5th. The rank is required by the federal government. National Guard or Reserves is not eligible. Retired military is not eligible.

Section 4. Parent, Step-Parent, or Legal Guardian Signature. This form must be signed and dated for our school district to receive these funds.
